*AI tools have made scams feel more personal,
more convincing, and harder to detect.*

IMPOSTOR SCAMS

Scammers pretend to be trusted officials to demand urgent payment or personal information.

2



AI-ENABLED SCAMS

Voice cloning, spoofed videos, and realistic messages trick you into taking action.

3



ROMANCE & COMPANIONSHIP SCAMS

Fraudsters build emotional connections to gain trust and request money or financial help.

4



INVESTMENT & CRYPTO SCHEMES

Fake opportunities promise high returns and pressure you to invest quickly and send funds.

5



TECH-SUPPORT & DEVICE TAKEOVERS

Scammers pose as tech support to gain remote access and steal information or money.

6



CAREGIVER & INSIDER EXPLOITATION

Trust is exploited by caregivers or insiders to misuse funds or personal information.

Protect Against Financial Exploitation and Abuse

Watch for warning signs — and take practical steps before problems escalate.



Watch for These Red Flags

-  Sudden changes in spending habits
-  New account access or beneficiary changes
-  Confusion about finances that didn't exist before
-  Pressure to make quick financial decisions



Be Proactive

-  Consolidate accounts where appropriate
-  Set up alerts or trusted contact authorizations
-  Separate spending accounts from core assets
-  Encourage periodic third-party reviews

When Cognitive Decline *Affects Financial Decisions*

This is about protecting you with care when financial choices become harder to navigate.



01 VERIFICATION

Confirm important requests so you know who you're really hearing from.



02 TRUST & PERSUASION

Recognize when kindness, familiarity, or flattery may influence your choices.



03 URGENCY & IMPULSE

Slow down when you feel pressure to act right away or avoid a negative outcome.



04 WORKING MEMORY

Hold and process multiple details without losing track of the big picture.



Checking twice

Confirm details through a trusted source before acting on any request. A second look can help prevent costly mistakes and gives you greater peace of mind.



Reading intent

Scammers and manipulators may sound convincing. Pay attention to tone, unusual requests, or pressure to keep things secret—these can be red flags.



Pausing under pressure

Urgent demands are designed to short-circuit your judgment. Take time to breathe, ask questions, and get another opinion before you commit.



Following complex instructions

Multiple steps or unfamiliar terms can be overwhelming. Break tasks into smaller parts, write them down, and review with someone you trust.

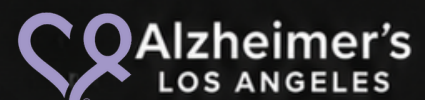
